TERMS AND CONDITIONS

Godolphin Australia Pty Ltd also trades as Darley, or Darley stallions.

"Australian Turf Club" is also referred to as ATC, the Club.

"ATC Darley Princess Series", is also referred to as Darley Princess Series, Series, Princess Series. "Winning breeder" is the person/s stated on the Australian Studbook as at the date of the race. Mare, broodmare, breeding thoroughbred horse.

Winning horse's breeder of each leg of the Series receives a nomination to a Darley stallion as specified for that race:

- a. The breeder is the person/s or entity stated on the Australian Studbook as the breeder at the date of the race.
- b. The nomination must be used in the 2021 or 2022 southern hemisphere breeding season.
- c. Nomination prize is non-transferrable, must be used by winning breeder.

2. 2021 Series nominations to the Darley stallions are as follows:

- Nominations for each leg are selected by Darley prior to the Series commencing and may be changed at any time at Darley's discretion.
- b. Darley stallion nominations for 2021:
- G2 Silver Shadow Stakes on 21 August is Earthlight valued at \$22,000 including GST.
- G2 Furious Stakes on 4 September is Ghaiyyath valued at \$27,500 including GST.
- G2 Tea Rose Stakes on 18 September is Microphone valued at \$38,500 including GST.
- G1 Flight Stakes on 2 October is Blue Point valued at \$44,000 including GST.
 - If the above race is rescheduled for any reason, Darley at its discretion will determine whether the nomination prizes are still applicable.
 - d. If the above races are cancelled under any circumstances, the nominations will be null and void.

3. In the event of a dead heat in any of the four legs of the Series.

- a. If a dead heat is declared as the official results by Racing NSW Stewards, it will be at the discretion of Darley:
 - (i) if both or no breeder wins the nomination prize.
 - (ii) whether each breeder receives a nomination at the full value, or if the value of the nomination is halved and/or an alternative stallion is selected for both breeders.

4. Darley stallion nominations for the 2021 Series:

- a. Should a stallion be unavailable or at Darley's discretion be made not available by Darley for any reason, Darley and the winning breeder will first discuss options for an exchange of the nomination to an alternate Darley stallion, and failing agreement Darley at its discretion will nominate the stallion.
- b. Nominations are non-transferable.
- c. Nominations are non-transferable for monies, must be used for breeding purposes, and only the winning breeder's mare is to be covered.
- d. The broodmare must be owned or part-owned by the winning breeder as recorded in the Australian Studbook.
- e. The nomination will be carried out on Darley's standard terms and conditions.
- f. The nomination does not include a live foal guarantee or free return terms in the event that the mare fails to become pregnant or fails to deliver a live foal.

5. Winning multiple legs of the Series:

a. The winning breeder per Term 1, section a, is entitled to receive and use the winning Darley nomination per Term 1, section a in respect to each leg of the Series.

6. Claiming the nomination prize:

- a. A member of the Darley stallions' nominations team will formally advise the winning breeder in writing of their nomination prize following each leg.
- b. The winning breeder is to provide, in writing, confirmation of the mare they would like to send to the Darley

stallion of their winning leg no later than 1 August in the year of service.

7. Series trophies:

- a. The ATC will provide the winning owner/s of each leg with a trophy per the Club's terms and conditions. Any replicas of the silverware are to be at the cost on the winning connections and requested via the ATC https://www.australianturfclub.com.a u/memorabilia/.
- Darley will provide the winning breeder/s of each leg with one framed image of the relevant Darley stallion for that leg per Term 2, section c.

8. Points system and Series Winner prize

- a. This filly who accumulates the most points throughout the four-leg Series will receive, subject to these Terms, a nomination to a Southern Hemisphere rostered and wholly owned Darley stallion standing at an advertised service fee of no more than \$132,000 inclusive of GST of her owner's choice.
- b. The nomination for the winning filly must be used in the southern hemisphere season which first follows the filly's retirement from racing.
- c. If the filly is sold at a public auction or through private treaty, the Darley stallion nomination will remain attached to her, and will be on the Terms as set out herein.
- d. In the event that all four legs of the Series are not run for any reason,
 Darley at its discretion may not award or may amend the prize.
- e. The point allocation is based on the official race results as stated by Racing NSW. Points are as follows:
 - First place receives seven points.
 - Second place receives three points.
 - Third place receives one point.
- f. In the event of a dead heat for either first place, second of third, both fillies will receive the full above stated points, points will not be halved.
- g. In the event two fillies for the Series are tied with the same total points, it is at the discretion of Darley whether both fillies receive a nomination,

whether the owners have full choice of the Darley stallions roster, or whether both fillies' owners are restricted to choosing from a stallion or stallions selected by Darley.

9. Darley stallion nominations for the 2021 Series Winner:

- a. Should a stallion be unavailable or at Darley's discretion be made not available by Darley for any reason, Darley and the winning breeder will first discuss options for an exchange of the nomination to an alternate Darley stallion, and failing agreement Darley at its discretion will nominate the stallion.
- b. Nominations are non-transferable.
- Nominations are non-transferable for monies, must be used for breeding purposes, and only the winning mare is to be covered.
- d. The nomination will be carried out on Darley's standard terms and conditions.
- e. The nomination does not include a live foal guarantee or free return terms in the event that the mare fails to become pregnant or fails to deliver a live foal.
